Ms. Petrilla made a motion to approve the minutes of the June, 18, 2024 meeting, which was seconded by Mayor Malkin and approved by the following vote:

Mayor & Council Update: Council is debating how to use grant money for a memorial project. Also working on a bond ordinance. Tim Hartley resigned from the Environmental Commission.

Environmental Commission Update: No report.

Ms. Roberts stated there are two parts of the storm water ordinance to be addressed: Defining minor development and addressing volume for major developments. The Board discussed defining minor development as projects that increase impervious coverage anywhere between 250-1000 square feet. The Board had some concerns about how storm water management regulations would affect the cost of projects and affect the residents. The Board would like to see examples of types of storm water management for residential projects such as drywells and rain gardens.

Susan Bristol, Municipal Policy Manager for the Watershed Institute, stated they have a model ordinance the town could review. Also suggested the Board take into consideration storm water regulations for redevelopment projects, not just new structures.

The Board decided that 400 square feet was a suitable number.

Ms. Roberts would also like to include language to address how volume is calculated for major developments. She felt there are ways it can be addressed through recharge systems.

Ms. Psarakis thought it would be helpful to have a public educational forum on how the regulations affect the residents.

Ms. Roberts will prepare some definitions and draft language to address both issues discussed for the Board to review at the next meeting.
